- by raising \$100 in sponsorship for the annual Walk-A-thon (during October 2024)

*Register Active Parishioners of Our Lady of Czestochowa and Charity parish may qualify for a \$300 tuition discount. The discount will be given in the following schedule:

1. \$150 discount on your December tuition payment
2. \$150 discount on your April tuition payment

Please remember that to be considered a registered, active, and contributing parishioner, one has to not only register but financially contribute to the parish using electronic funds transfer or by dropping your donation in specially provided envelopes. The envelope system tracks both Mass attendance and giving. We have parishioners who sometimes find themselves for short or longer periods unable to give, but they still drop their envelope in the basket, to show that they were here. Every year, we look at those who are registered in the parish, and if there is no discernible activity via EFT or envelopes, they are reduced to inactive status. This is also important so that the Archdiocese does not assess Our Lady of Czestochowa and Charity for inactive parishioners.
